- b) The bidders should also furnish bid security or EMD for an amount of Rs. 1,000/- (One thousand) only along with the tender in the form of Account Payee Demand Draft or Fixed deposit Receipt from a Commercial or Nationalized bank in favour of the Commissioner, Shillong.
- c) The bid security or EMD of unsuccessful bidders will be returned within one month of opening of bids, without any interest.
- d) Overwriting of amount quoted shall have to be countersigned by the bidder/authorized signatory.
- e) GST or any other tax if applicable shall be borned by the successful bidder under Reverse Charges Mechanism (RCM)..
