No. ERTS (T) 81/2014/Pt./24 - In supersession to the Government Notification No. ERTS(T)81/2014/129 dated 08.02.2021 and in exercise of the powers conferred by Section 3 of the Meghalaya (Sales of Petroleum products including Motor Spirit) Taxation Act, (Assam Act IX of 1956 as adapted and amended by Meghalaya), the Governor of Meghalaya is pleased to modify and revise the rate of tax on Goods specified in the schedule of the Act aforesaid and to further specify that the rate of tax as indicated in the schedule below will come into force with effect from midnight of 16th February, 2021.

SCHEDULE

Sl. No.	Description	Rate of Tax	Remarks
1.	Motor Spirit (except diesel oil and other internal combustion oils other than petrol).	20% or Rs. 15/- (Rupees fifteen) only per litre whichever is higher	Sales surcharge of 2% on tax payable at ad valorem rate only.
3.	Diesel oil and other internal combustion oils.	12% or Rs.9/- (Rupees nine) only per litre whichever is higher	Sales surcharge of 2% on tax payable at ad valorem rate only.

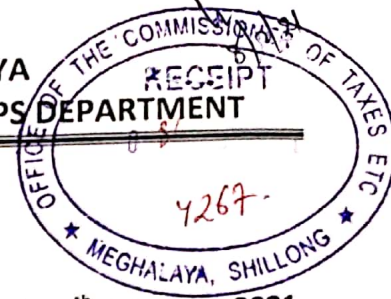

Dated Shillong, the 8th February, 2021.

No. ERTS (T) 81/2014/129 - In exercise of the powers conferred by Section 4 of the Meghalaya (Sales of Petroleum products including Motor Spirit) Taxation Act, (Assam Act IX of 1956 as adapted and amended by Meghalaya), the Governor of Meghalaya is pleased to exempt in the public interest the dealers in Motor Spirit (Petrol) and High Speed Diesel, registered with the concerned Superintendent of Taxes from payment of part of the tax payable on sales of Motor Spirit (Petrol) and High Speed Diesel within the State of Meghalaya @₹2/- (rupees two) only per litre with effect from midnight of 8th February, 2021.

This exemption is subject to the condition that the retail price of Motor Spirit (Petrol) and High Speed Diesel shall be reduced by ₹2/- (Rupees two) only per litre.


