No. ERTS (T) 39/2008/159 - In exercise of the powers conferred by Section 4 of the Meghalaya (Sales of Petroleum and Petroleum products including Motor Spirits and Lubricants) Taxation Act, (Assam Act IX of 1956 as adapted and amended by Meghalaya) the Governor of Meghalaya is hereby pleased to exempt in the public interest, the Oil Companies and retail outlets registered as dealers with the concerned Superintendent of Taxes from payment of part of the tax payable on sales of motor spirit within the State of Meghalaya @ ₹. 1.13 paise per litre with effect from 15.06.2012

This exemption is subject to the condition that the retail price of motor spirit shall be reduced by ₹. 1.13 paise per litre.
