**NOTIFICATION**

Dated Shillong, the 3<sup>rd</sup> Sep, 2012

No. ERTS (T) 27/2003/21 In supercession of the Government Notification No. ERTS(T) 27/2003/9, dt. 27.07.2005 and in exercise of the power conferred by sub-section (1) of Section 25 of the Meghalaya Value Added Tax Act, 2003 (as amended), the Governor of Meghalaya is pleased to reallocate the areas as demarcated below for exercising jurisdiction by the Superintendent of Taxes, Shillong with immediate effect.

Circle - I	Whole of the Barabazar, Mawlonghat, Sweeper Lane upto Thangkhiew Petrol Pump, all areas opposite Thangkhiew Petrol Pump including Bimola, Fine Walk etc., Lower portion of Nichols Roy Building upto Motphran Point and Areas under Shella Bholaganj Development Block.
Circle - II	Police Bazar area including Thana Road and Quinton Road upto the point opposite of the old Singhania Cinema, and areas under Mawphlang Development Block.
Circle - III	Starts from DCM Building (Umsohsun) both sides of G.S. Road upwards to Sweeper Lane (up to Thangkhiew Petrol Pump), all areas opposite Nichols Roy Building upto Mawkhar Police Point, Mawkhar Police Point all areas opposite Jeepstand, Qualapati, Lamavilla, Mawkhar, Jaiaw, Wahingdoh, Umsohsun, Riatsamthiah, Sunny Hill, Mawlai, Mawiong and areas under Mawsynram Development Block.
Circle - IV	29-A Cantonment, upto the drain adjacent Hills Hardware and Rani hotel, Upper Shillong, areas under Myllem Development Block (excluding those areas specifically mentioned in other Circles).
Circle - V	Paltan Bazar, Luckier Road, Jhalupara, Barapathar, Mawprem all areas of Jeepstand opposite Barabazar, Jeepstand left side opposite Qualapati upto District Council Point and areas under Mawkynew Development Block.
Circle - VI	Dhankheti, Malki, Nongthymmai, Happy Valley, Madanrting, Umpling, Jingkieng, Nongrim Hills, Rynjah, Pohseh, Risa Colony, Fruit Garden, Motinagar, Laitkor and areas under Mawryngkneng Development Block.
Circle - VII	Laban, Kench's Trace, Rilbong, Bishnupur, Lawsohtun, Keating Road, European Ward, Upper and Lower Lachumiere, Lumapring, Kachari Road, inclusive of all areas opposite Meghalaya Legislative Assembly and Presbyterian Church Police Bazar and Areas under Laitkroh Development Block.
Circle - VIII	Laitumkhras, Polo, Golfink, Pynthorbah, Langkyrding, Nongmysong, Mawpat, Jail Road, Oakland and areas under Pynursla Development Block.

N.B :- Senior-most Superintendent of Taxes, Shillong shall be in-charge of Non-resident dealers in accordance with the delegation of powers by the Commissioner of Taxes, Meghalaya Shillong.
