**No. ERTS(T) 4/2019/242 -** In exercise of the powers conferred by sub-sections (1), (3) and (4) of section 9, sub-section (1) of section 11, sub-section (5) of section 15, sub-section (1) of section 16 and section 148 of the Meghalaya Goods and Services Tax Act, 2017 (Act 10 of 2017), the Government of Meghalaya, on the recommendations of the Council, and on being satisfied that it is necessary in the public interest so to do, hereby makes the following further amendments in the notification of the Government, No. ERTS.65/2017/11, dated the 29<sup>th</sup> June, 2017, published in the Gazette of Meghalaya, Extraordinary, Part II A, *vide* number 98, dated the 5<sup>th</sup> July, 2017, namely:-

In the said notification, -

- (i) in the Table, against serial number 3, in items (ie) and (if), in the entry in column (5), the figures and letters “10<sup>th</sup>”, wherever they appear, shall be substituted by the figures and letters “20<sup>th</sup>”;
- (ii) in Annexure IV, the figures and letters “10<sup>th</sup>”, wherever they appear, shall be substituted by the figures and letters “20<sup>th</sup>”.

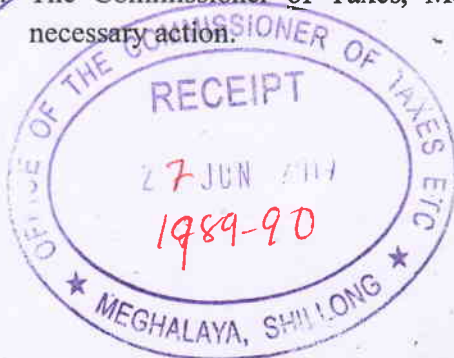



