No. ERTS(T) 4/2019/416 - In exercise of the powers conferred by sub-section (1) of section 11 of the Meghalaya Goods and Services Tax Act, 2017 (Act No. 10 of 2017), the Government of Meghalaya, on the recommendations of the Council, hereby makes the following amendments in the notification of the Government of Meghalaya No. 26/2018-State Tax (Rate) issued vide No. ERTS(T)65/2017/471, dated the 31st December, 2018, published in the Gazette of Meghalaya, Extraordinary, Part IIA, *vide* number 14, dated the 18th January, 2019, namely:- In the said notification, -

- (i) for the word "gold", wherever it occurs, the words, "gold, silver or platinum", shall be substituted;
- (ii) in the opening paragraph, for the word and figures, "heading 7108", the word and figures, "Chapter 71", shall be substituted;
- (iii) in the Explanation, for clause (d), the following clause shall be substituted, namely: —. "(d) "Chapter" means heading as specified in the First Schedule to the Customs Tariff Act, 1975 (51 of 1975).".
- 2. This notification shall come into force on the 1st day of October, 2019.


