No.ERTS(T)65/2017/Pt-III/Vol-I/650- In exercise of the powers conferred by sub-section (3) of section 9 of the Meghalaya Goods and Services Tax Act, 2017 (10 of 2017), the State Government, on the recommendations of the Council, hereby makes the following further amendments in the notification of the Government of Meghalaya, Excise, Registration, Taxation & Stamps Department of Meghalaya No.ERTS(T) 65/2017/04, dated the 29th June, 2017, published in the Gazette of Meghalaya, Extraordinary, Part II A,, vide number 91, dated the 05th July, 2017, namely:-

In the said notification, in the Table, against S. No. 6, in column 4, for the entry, the following entry may be substituted, namely: -

“Central Government [excluding Ministry of Railways (Indian Railways)], State Government, Unionterritory or a local authority.”


