**No.ERTS(T)65/2017/Pt-III/Vol-I/651-** In exercise of the powers conferred by clause (ii) of the proviso to sub-section (3) of section 54 of the Meghalaya Goods and Services Tax Act, 2017 (10 of 2017), the State Government, on the recommendations of the Council, hereby makes the following further amendments in the notification of the Government of Meghalaya, Excise, Registration, Taxation & Stamps Department of Meghalaya No.ERTS(T) 65/2017/05, dated the 29th June, 2017, published in the Gazette of Meghalaya, Extraordinary, Part II A, vide number 92, dated the 05<sup>th</sup> July, 2017, namely :-


