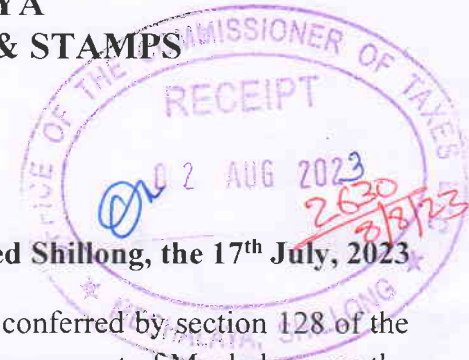

**No. ERTS (T) 65/2017/Pt III/Vol I/443** - In exercise of the powers conferred by section 128 of the Meghalaya Goods and Services Tax Act, 2017 (Act 10 of 2017), the Government of Meghalaya, on the recommendations of the Council, hereby makes the following further amendments in the notification of the Government, Excise, Registration, Taxation & Stamps Department, No.ERTS (T) 65/2017/Pt/159, dated 2<sup>nd</sup> January, 2018 published in the Gazette of Meghalaya, Extraordinary, Part II A, *vide* number 22, dated the 29<sup>th</sup> December, 2017, namely: —

In the said notification, in the seventh proviso, for the words, letter and figure “30<sup>th</sup> day of June, 2023” the words, letter and figure “31<sup>st</sup> day of August, 2023” shall be substituted.
