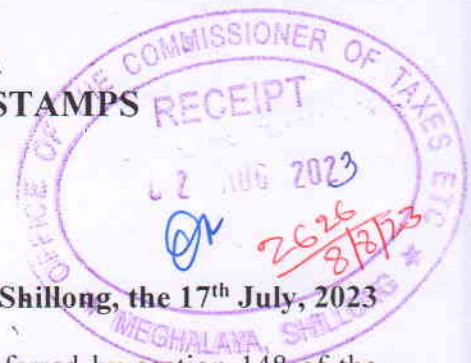

**No. ERTS (T) 65/2017/Pt III/Vol I/444** - In exercise of the powers conferred by section 148 of the Meghalaya Goods and Services Tax Act, 2017 (Act 10 of 2017), the Government of Meghalaya, on the recommendations of the Council, hereby makes the following further amendments in the notification of the Government, Excise, Registration, Taxation & Stamps Department, No. 03/2023– State Tax, dated the 31<sup>st</sup> March, 2023 published in the Gazette of Meghalaya, Extraordinary, Part II A, *vide* number 129, dated the 28<sup>th</sup> April, 2023, namely: —
