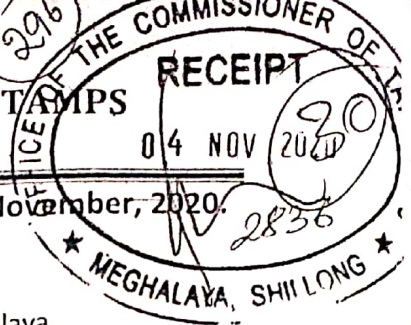

No. ERTS (T) 56/2020/12 - In pursuance of Government Notification No. ERTS (T) 85/99/Pt/126, dated 31.8.2005, the Governor of Meghalaya is pleased to direct that all retailers of Indian Made Foreign Liquor (IMFL)/wine/beer/BIO etc. paying tax under Sl.No. 1 of Schedule V appended to the Meghalaya Value Added Tax Act, 2003, last amended vide Notification No. ERTS (T) 24/2016/58, dated 15.3.2017, published in the Gazette of Meghalaya, Extraordinary, Part II A vide No. 19, dated 15.3.2017 are to deposit the tax payable and to furnish a copy of the Treasury Challan receipt or GRAS receipt to the concerned authority under the Excise Department, Government of Meghalaya, before the Retail Import Permit is issued by the said concerning authority.

This notification shall come into force with immediate effect.
