**NOTIFICATION**

No. ERTS (T) 36/2023/22 - In supersession of Government Notification No. ERTS(T)56/2020/12 dated 25.8.2020, the Governor of Meghalaya is pleased to direct that all Bonded Warehouses licensed to deal in Indian Made Foreign Liquor (IMFL)/ wine/ beer/ BIO etc shall pay tax under serial no.1 of Schedule V appended to the Meghalaya Value Added Tax Act, 2003, last amended vide No. ERTS (E)3/2022/121 dated 1.6.2022, under the Meghalaya Value Added Tax Identification Number of the Central Bonded Warehouse and are to furnish a copy of the Treasury Challan receipt or GRAS receipt evidencing the tax paid, calculated at the applicable rate of tax on the Invoice value of the Central Bonded Warehouse, to the concerned authority under the Excise Department Government of Meghalaya, before the import permit is issued by the said concerning authority.

This notification shall come into force with immediate effect.


